We are excited to invite you to the 2009 MidWinter Gathering of Friends for Lesbian, Gay, Bisexual, Transgender, and Queer Concerns to be held on the western edge of our continent at Camp Adams in Molalla, Oregon.

We encourage you to register for the full weekend; we need 100 registrants to get the rates listed below. We will also appreciate participation from those who can only attend part-time. Here's the bottom line on arrangements and costs.

Lodging: All lodging will be distributed based on need, not financial contribution. Most beds are single bunks in cabins; there are a few semi-private rooms. You will be assigned beds based on the information you give us about your needs.

Full Weekend Registration: includes three nights lodging, all meals and facility fees; sliding scale suggested – set your own rate
